**If You Have Received a Payment from BP America Production Company for Production from an Oil and Gas Well in Oklahoma, You Could Be a Part of a Proposed Class Action Settlement.**

**Who Is Included?**

You may be a member of the Settlement Class if you received payments for proceeds for the sale of oil or gas production from Defendant (or Defendant's designee) for wells in the State of Oklahoma later than the time periods required by Oklahoma law and whose payments did not include the full amount of the interest owed thereon, or you had proceeds which were suspended or paid to a state as unclaimed property by Defendant (or its designee) and interest was not accrued or paid thereon. The Class has been preliminarily approved for settlement only. There are exclusions.

There is a proposed Settlement in a putative class action lawsuit filed against BP America Production Co. ("Defendant") called *Chieftain Royalty Co. v. BP America Production Co.*, Case No. 18-cv-54-JFH-JFJ, in the U.S. District Court for the Northern District of Oklahoma. The Lawsuit claims Defendant failed to accrue and/or pay statutory interest on suspended proceeds and payments made outside the time periods of the Production Revenue Standards Act ("PRSA") for oil and gas production proceeds from wells in Oklahoma. Plaintiffs have asserted claims for breach of the PRSA, fraud, accounting/disgorgement, and injunctive relief, and seek actual and punitive damages. Defendant denies all liability.

**Why am I receiving this notice?**

Defendant's records indicate you may be a member of the Settlement Class.

**What does the settlement provide?**

The proposed Settlement provides monetary benefits of \$15,000,000.00 that will be distributed according to the terms of the Settlement Agreement, the documents referenced in and exhibits to the Settlement Agreement, and orders from the Court. Plaintiff's Counsel will seek attorneys' fees up to \$6,000,000.00; reimbursement of litigation expenses up to \$600,000.00; and Administration, Notice, and Distribution Costs up to \$400,000.00, all to be paid from the Settlement. Plaintiffs will seek a contribution award up to \$150,000.00 from the Settlement.

**What are my legal rights?**

You do not have to do anything to stay in the Settlement Class and receive the benefits of the proposed Settlement. If you stay in the Settlement Class, you may also object to the proposed Settlement and requests for attorney fees, expenses, and case contribution award by following the instructions from the Court (available on the website) by **February 4, 2022**. If you stay in the Settlement Class, you will be bound by all orders and judgments of the Court, and you will not be able to sue, or continue to sue, Defendant or others identified in the Settlement Agreement from claims described therein. You may appear through an attorney if you so desire.

**What are my other options?**

If you do not wish to participate in or be legally bound by the proposed Settlement, you may exclude yourself by opting out by **February 4, 2022**, by following the instructions from the Court (available on the website). If you opt out, you will not receive any benefits from the Settlement and will not be bound by it or the judgment in this case.

**When will the Court decide whether to approve the proposed Settlement?**

A Final Fairness Hearing has been scheduled for **February 25, 2022**, at 1:30 p.m. CT at the United States District Court for the Northern District of Oklahoma, 333 W. 4th Street, Tulsa, Oklahoma 74103. You are not required to attend the hearing, but you or your lawyer may do so if you wish.
